



Applications will be assessed on first come, first served basis. Furthermore, payments, if any, are subject to approval of the project by way of a separate letter from the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA); Ontario receiving all the necessary appropriations from the Ontario Legislature; Ontario receiving all the necessary monies from Canada; the Applicant and the Applicant's project (including all activities) satisfying all of the eligibility criteria; eligible expenses criteria; as well as the Applicant's compliance with all terms and conditions of the Initiative and the Agreement.
- Any funding received will be used exclusively for the activities proposed by you to increase your capacity to manage deadstock, and may not be amended, varied or changed or deviate in any material way from the activities described by you in this application;
- The Ministry has a right to suspend and recover funding for your Project if you have amended, varied or changed or have deviated from your proposal in a material way such that you do not continue to meet the Partnership's and the Initiative's criteria;
- If it is determined the Applicant has received a payment the Applicant was not eligible to receive, through administrative error or otherwise or by reason of noncompliance with the terms and conditions of the Contribution Agreement (as described below), the Applicant will repay any and all payments as well as any surplus funding plus accrued interest upon it forthwith upon demand.
- Any payments made or payable to the Applicant may be subject to recovery or set-off against the Applicant's pre-existing debts to the Crown in Right of Ontario or Canada.
- There will be a ten per cent (10%) holdback on any reimbursement until a final report for the Project, in such form and with such content as OMAFRA shall determine, is received and approved by OMAFRA. At a minimum, the final report submitted for the Project will include an attestation that the Project has been completed as approved and has complied with the requirements of the Initiative.
